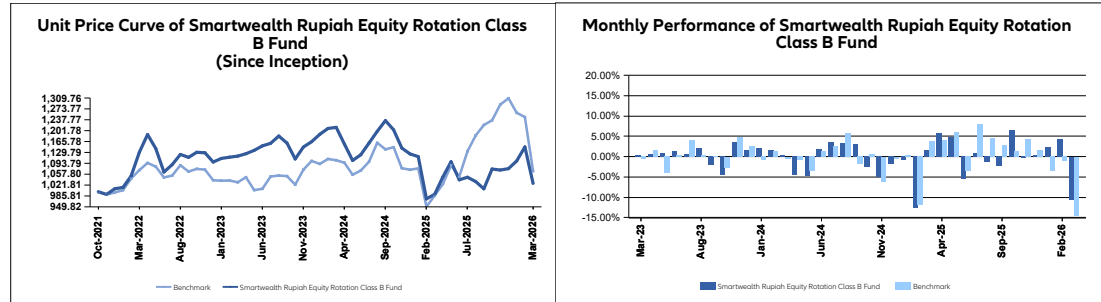

### Manager Commentary

Global equities recorded lower in the month of March 2026. Major global indices such as the S&P 500 Index, Dow Jones Industrial Index, Nasdaq Composite Index, and MSCI ACWI Index recorded a return of -5.09%, -5.38%, -4.75%, and -7.36% respectively. Global equities are filled with negative sentiments in March, due to the ongoing tension in the middle east. Combined with the closure of the strait of Hormuz, energy prices spiked, and disrupted supply of energy going out from the gulf. Federal Reserve have kept the rate unchanged, with a wait and see stance, given that inflation is expected to rise, due to rising energy price. Jakarta Composite Index recorded a return of -14.42% in the month of March 2026, all sectors were down in the month of March, with the basic material sector recorded the biggest drop. Bank Indonesia kept the rate unchanged at 4.75% in their latest March meeting. Further highlighting the importance of foreign exchange stability. Indonesia government bond yield closed at 6.88% at the end of March 2026.

Jakarta Composite Index recorded a return of -1.13% in the month of February 2026, infrastructure sector is the biggest detractor, while basic materials sector is the strongest contributor. Volatility continued in February 2026, mainly caused by negative outlook set by Moody's in Indonesia sovereign rating. On top of that, the month is also highlighted by new capital market initiatives announced by IDX, to increase transparency. Bank Indonesia kept the rate unchanged at 4.75% in their latest February meeting. Indonesia government bond yield closed at 6.43% at the end of January 2026, up around 10 bps from previous month.
